# BC SCHOOL SPORTS 41st ANNUAL GENERAL MEETING MINUTES Saturday May 9, 2009 at George Elliot Secondary

- 1. CALL TO ORDER: (Raj Puri, President, (Kwantlen Park Secondary School)
  - 1.1. <u>Welcome and Opening Remarks:</u> The President welcomed all delegates and observers to the 41st Annual General Meeting. He Thanked Doug Meraw and George Elliot for hosting.
  - 1.2. <u>Meeting Information and Announcements:</u> General information about the meeting and announcements for the day's proceedings were made by Raj Puri.
  - 1.3. <u>Introductions:</u> The President introduced members of the BC SCHOOL SPORTS Board of Directors. The list of registered voting delegates and registered observers is found in Appendix A and B.
  - 1.4. <u>Declaration of Voting Rights, Rules of Order and Appointment of Parliamentarian and Scrutineers</u>: (Randy Semenoff, Vice President)
    - 1.4.1. <u>Voting Rights:</u> Each qualifying school who is a member in good standing as of March 31, 2009 can exercise a vote at the BCSS Annual General Meeting, through duly registered proxies or by voting in person. (Article 6 Bylaw 6.5)
    - 1.4.2. <u>Rules of Order:</u> In accordance with Bylaw XXII, the meeting will use the latest edition of Robert's Rules of Order for any procedural issue for which provision or partial provision has not been made in the Bylaws.
    - 1.4.3. Appointment of Scrutineers and Parliamentarian: Several individuals volunteered to keep track of the voting numbers throughout the Resolutions discussion. They were: **Sue Thorne, Randy Semenoff, and Joe Moreira.** Mr. **Barrie Lynch**, the Parliamentarian who will be chairing the resolution portion of the meeting, was also introduced.
  - 1.5. Nomination Procedures for the Board of Directors: (Randy Semenoff, Vice-President) In accordance with Bylaw 7.2, all properly executed nomination forms had to be received at the BCSS office by March 24, 2009. (Nominations will not be accepted from the floor.) Elected Director positions available for nomination were:
    - 1. 5.1 2<sup>nd</sup> Vice-President
    - 1. 5.2 Athletic Association Presidents as elected by the Presidents and
    - 1.5.3 Sport Commissioner –Tennis as previously agreed to on a rotational basis.
  - 1.6. <u>Outline of Resolution Procedures:</u> (Raj Puri, President) Special Resolutions (dealing with Constitution or Bylaw changes) were due at the BCSS office by March 24, 2009 (Bylaw 18.2.2). Other resolutions were due on March 31, 2009. (Resolutions to change the Constitution & Bylaws, Membership Fees, Operating or Competitive Policies will **NOT** be accepted from the floor.)
  - 1.7. Announcement of Registered Votes: The full BCSS Membership is 428 schools as of March 31, 2009. A quorum (20%) is 86 votes. 162 votes are present, in person or by proxy. A simple majority of votes (more than 50% of votes) is 82; and 75% of votes is 122.

There are 36 votes represented in person, 126 votes are represented by proxy.

7. RESOLUTIONS: Presided over by Mr. Barrie Lynch, Parliamentarian.

Barrie Lynch gave background on being a professional parliamentarian and advised that he will be using the newest edition of Roberts Rules (10<sup>th</sup> edition). Every person will have the opportunity to speak (up to 10min). There will be an additional opportunity to speak a second time but only after everyone has spoken once. He will be using a consent motion – if everybody is in agreement, the motion will be passed by consent. All comments will be directed through the parliamentarian, and he will ensure that comments will be made to the issue rather than to individuals. As parliamentarian, he is striving to achieve representation from the majority of the organization in attendance today. He spoke to the specific bylaws as to what percentage is required to pass a motion or make amendments.

- 3. WHEREAS, the overall expenditures of the organization has been rising steadily over the past two years.

**MOVED: (SEMENOFF, (Brocklehurst) / THORNE, (Prince Charles))** BE IT RESOLVED that there be a membership fee increase of three (3%) percent in 2010-2011.

4. WHEREAS, the Legal Contingency Fund as of March 31, 2009 is at approximately \$30.000.00;

**AND** 

WHEREAS, BCSS Operating Policies state that the Legal Contingency Fund shall remain around \$50.000.00;

- **5.** Section F Championship Standards (pages 105-116)

WHEREAS, there is a need to update and clarify certain parts of this section as a part of the overall review process;

**MOVED: (BECKER, (North Delta) / KEENAN, (Samuel Robertson))** BE IT RESOLVED that Section F6.3.2 be approved as noted below as confirmed by all commissions as still necessary.

F6.3.2	Blanket Exemptions:
a)	the BC Secondary Schools Skiing Association is granted a blanket exemption from <b>F6.3.1</b> for the Alpine Skiing and Snowboarding Championships, provided that the championship event(s) either starts on a Monday or concludes on a Friday. This is to facilitate team travel to or from the event on a weekend
b)	the BC Secondary Schools Golf Association is granted a blanket exemption from <b>F6.3.1</b> for the Golf Championship, provided that the championship event either starts on a Monday or concludes on a Friday. This is to facilitate team travel to or from the event on a weekend
c)	the BC Secondary Schools Soccer Association is granted a blanket exemption from <b>F6.3.1</b> for the Girls' AA and AAA Soccer Championships, provided that the championship events start on a Sunday and end on a Tuesday
d)	the BC Secondary Schools Soccer Association is granted a blanket exemption from <b>F6.3.1</b> for the Boys AA and AAA Soccer Championships, provided that the championship starts on a Monday or ends on a Friday, in order to accommodate facility bookings and conflicts with community users.
e)	the BC Secondary Schools Girls Field Hockey Association is granted a blanket exemption from <b>F6.3.1</b> for the AA and AAA Field Hockey Championships, provided that the events either start on a Monday or end on a Friday. This is to facilitate team travel to or from the events on a weekend.
f)	the BC Secondary Schools Rugby Union is granted a blanket exemption from <b>F6.3.1</b> for the Boys' AA and AAA Rugby Championships, provided the championship starts on a Wednesday and ends on a Sunday to accommodate a day of rest due to safety concerns.

# **6.** Section E2.2 – Designated Seasons of Play by Sport and Area (page 100)

WHEREAS, a request has been received from the South Okanagan Athletic Association requesting that grade 8 Volleyball be played in the spring season of play. This exemption is already occurring in several other jurisdictions to facilitate facility access;

**MOVED: (BECKER, (North Delta) / KEENAN, (Samuel Robertson))** BE IT RESOLVED that the South Okanagan Athletic Association (correct athletic association – **Central Okanagan**) be allowed to move their Grade 8 Volleyball to the spring season of play.

Rob Colombo spoke in explanation of this resolution and advised as to a possible error in the correct party being identified as submitting the resolution. He requested the resolution be deferred to the CSC and that once the 'mover' (the Athletic Association that submitted this resolution is correctly confirmed) approval be given.

VOTE: 79 For 36 Opposed

Mr. Barrie Lynch – Parliamentarian provided clarification on the process concerning this upcoming resolution.

7. Part E – Seasons of Play: E2.2 – Designated Seasons of Play by Sport and Area (page 100)

A) WHEREAS, there is a desire to address the need for a competitive balance;

#### AND

WHEREAS, there is a desire to regulate that no student has greater than a 13 week season of play in any specific school sport;

#### **AND**

WHEREAS, the purpose of 'school sports' is to provide a variety of opportunities to participate in different athletic activities in different seasons of play;

#### AND

WHEREAS, movement between teams (Section D4, page 78-80) can only occur in one season of play, opportunities for junior players to move up during the season and post season as well as jointly sponsored teams and players playing at two levels – can only occur if seasons of play are aligned;

#### AND

WHEREAS, there is conflict between school sport programs and non-school sport programs in terms of seasons played;

MOVED: {COLOMBO, (Riverside) / THORNE, (Prince Charles)} BE IT RESOLVED that all Junior Competition (Grade 10) shall be played in the same season of play with the designated senior season of play.

M. Penner (Spectrum), M. Alina (Point Grey), H. Lederis, and M. Brown spoke in opposition to this resolution

Rob Colombo explained the rationale behind the motion.

VOTE: 102 For 38 opposed

**CARRIED** 

As a result of the first motion being accepted by the membership the second motion is now moot.

B) WHEREAS, the seasons of play existing in 2008/09 do allow Athletic Associations some freedom for placing junior leagues, thereby spreading out the demands placed on facilities (fields) and officials, and coaches (which are all in short supply) The problem does exist however, that in some schools, Junior aged players in Soccer and Rugby cannot be used in Sr. Play, and as a result, many schools are unable to field teams at the junior or senior level (or teams fold as there are no spare players to cover absenteeism or injury). Both these sports have a larger team size.. It is happening that many students are turned away from playing on a soccer or rugby team, for the lack of 2 or 3 players.

#### **AND**

WHEREAS, a rule already exists for Football, to allow students to participate in more than one age group, thereby acknowledging that at some situations, there is need to make exceptions to the rules, in order to allow a school to field a team. The exception allows BCSS to increase participation and support the goals of the Association.

#### **AND**

WHEREAS, the number of groups involved in the approval process, will weed out any situation that does not deserve of the exception. Teams that do not need the "jr" to survive are not likely to be approved by the local athletic Association or the Provincial Sport Commission.

MOVED: {PENNER, (Spectrum), / REISIG, (Claremont)} BE IT RESOLVED that D4.6 be revised as follows:

D4.6 Individuals playing at two levels of competition in the same season of play (or a different season):

If it is deemed necessary to have players compete at two different levels in order to field teams, an exception can be made with written approval from the parent/legal guardian, Administration, local Athletic Association and the Provincial Sport Commission.

**8.** A) Soccer Boys and Girls – Single "A" Provincial Championships expansion from 12-16 teams.

WHEREAS, in the interest of fairness and equal opportunity of representation for all zones,

**AND** 

WHEREAS, to maintain consistency with the AA and AAA tiers at the provincial soccer championships,

**MOVED: (PORPACZY, (Southridge) / SCHULTING, (Osoyoos))** BE IT RESOLVED that the number of participating schools at the "A" Boys and Girls Soccer Championship be increased from 12 to 16.

**CARRIED** 

B) Basketball: Girls – Single "A" Provincial Championships expansion from 12-16 teams.

WHEREAS, when the 'A' tier was created in both boys' and girls' basketball, the tournaments were eight-team competitions. Each of the seven zones received one berth with the host assigned the remaining one. As the number of registered 'A' girls' teams increased through the 1990's (39 in 1996-97 to 52 in 2000-01), the tournament was expanded to twelve teams.

#### AND

WHEREAS, the number of 'A' teams has continued to slowly increase over the last six years. This trend has been leading to discussion about increasing the 'A' girls' field to sixteen teams.

At last year's 'A' membership meeting during the provincial tournament in Keremeos, the coaches supported unanimously the concept of expanding the 'A' tournament to sixteen teams, a topic that had been discussed at the previous two tournament meetings.

#### **AND**

WHEREAS, the BCSSGBA Executive directed John Mill, its 'A' representative to survey the 'A' Girls coaches about the expansion. A copy of the survey and the compilation of the results are included at the end of this document. About half of this season's active teams responded, with 93% in favour of expansion. This led to the following motion being passed at this year's AGM on March 13.

**MOVED: (COLOMBO, (Riverside) / KEENAN, (Samuel Robertson))** BE IT RESOLVED that the expansion of 'A' girls basketball for the Provincial Championships be increased from a 12 to 16 team tournament.

Jim Mitchell on behalf of Abbotsford Christian spoke in opposition citing increased cost burdens.

# D) PROPOSED RESOLUTIONS FOR THE 2009 BCSS AGM FROM THE RULES AND REGULATIONS COMMITTEE.

**9.** House Keeping items- Amended changes in terms of title

MOVED: {THORNE, (Prince Charles) / MCLEOD, (Sullivan Heights)} BE IT RESOLVED that

Section 5.6 of the Operating Policies and Procedures be amended as follows:

- (a) the phrase "Jury of Appeal" be replaced throughout with "Eligibility Appeals Committee";
- (b) 5.6.3 be repealed and replaced with the following:
  - The Eligibility Appeals Committee hears appeals from decisions of the Eligibility Officer in accordance with Section D13 of the Competitive Rules and Regulations.
- (c) the following be added to the definitions section of the Competitive Rules and Regulations:
  - Eligibility Officer: The Eligibility Officer appointed by BCSS.
- (d) the Competitive Rules and Regulations be amended as necessary to reflect:
  - (i) the change from Compliance Officer to Eligibility Officer;
  - (ii) the change from Jury of Appeal to Eligibility Appeals Committee; and,
  - (iii) the change from Eligibility Appeal to Eligibility Exemption Application.

CARRIED

# **10.** Section D5: Student Gender (page 80)

WHEREAS, the Rules and Regulations Committee ("the Committee") has reviewed the BCSS eligibility rules (D5) pertaining to student-athlete gender;

#### **AND**

WHEREAS, in contrast to most BCSS eligibility rules, which are generally sport-neutral, the rules pertaining to gender are sport-specific since they are based on the various rules or formats of the different Sport Commissions:

#### AND

#### WHEREAS, the Committee is of the view that;

- (i) the different technical and other considerations applicable to different sports mean that there cannot be a "one size fits all" gender rule applicable to all sports,
- (ii) the Sport Commissions are best positioned to regulate gender matters in their respective sports,
- (iii) the regulation of gender matters should be a matter exclusively for the Sport Commissions, and,
- (iv) to avoid a lack of regulation, the current BCSS rules should remain in place until the Sport Commissions review their respective rules;

#### MOVED: {THORNE, (Prince Charles) / MCLEOD, (Sullivan Heights)} BE IT RESOLVED that

1. Rule A1.11 be repealed and replaced with the following:

Aim for equal opportunities in athletic programming for boys and girls, having regard to factors including funding, equipment, facilities, practice and competition time, coaching demand, available competition, and the range of sports offered.

- The Sport Commissions, with the assistance of BCSS, review their respective Bylaws and Rules pertaining to gender for the purpose of ensuring compliance with human rights legislation while advancing their and BC SCHOOL SPORTS' goals.
- 3. The following be added as D5.2:

If there is a conflict between D5.1 and a bylaw, rule or similar provision of a Sport Commission, the bylaw, rule or similar provision prevails.

- 4. In D1;
- i) the words "and any applicable Sport Commission gender-based eligibility rule" be added after "BCSS".
- ii) D1.2.1 be repealed and replaced with "they are ineligible under Part D of these rules, or".

**CARRIED** 

**11.** Section C7: Tiering Classification (page 74)

WHEREAS, the Ministry of Education has changed its funding formula;

MOVED: {THORNE, (Prince Charles) / MCLEOD, (Sullivan Heights)} BE IT RESOLVED that C7.1.1.a) read;

a) students in grades 11 and 12, and ungraded students in their fourth (4<sup>th</sup>) or fifth (5<sup>th</sup>) years of eligibility who are full time (75% course load – see D2.2) and are under nineteen (19) years of age as of December 31<sup>st</sup> of the current school year.

**CARRIED** 

**12.** House-keeping - Language / Verbiage changes throughout (pages 69...)

WHEREAS, there needs to be a consistent word usage in the Competitive Rules and Regulations;

**AND** 

WHEREAS, student, student-athlete, and player are used interchangeably;

**AND** 

WHEREAS, private school and independent school are used interchangeably;

**AND** 

WHEREAS, league play and restricted competition are used interchangeably;

**AND** 

WHEREAS, principal and administrator are used interchangeably;

MOVED: {THORNE, (Prince Charles) / MCLEOD, (Sullivan Heights)} BE IT RESOLVED that throughout the competitive rules and regulations:

- a) "student-athlete" be used to delineate a student participating in school athletic programs
- b) "non-public" be used to delineate schools that are not categorized as public

- c) "restricted competition" be used to replace league play in the competitive rules and regulations
- d) "administrator" be used to delineate the Administrative head of a school

**CARRIED** 

# 13. D12 Student Transfers - Student Eligibility (page 84-91)

WHEREAS, the Rules and Regulations Committee recommends that the provisions concerning studentathlete eligibility and the procedures for attaining eligibility be clarified and simplified;

#### **AND**

WHEREAS, there is a need to clearly articulate the intent and spirit of a 'principal residence move';

#### **AND**

WHEREAS, the present requirement that legal guardianship be in place for 12 months can be unfair and unnecessary in many instances;

#### AND

WHEREAS, the Committee believes that it would be in the interests of student-athletes for member schools to be able to obtain a binding ruling on eligibility in cases of uncertainty, in advance of competition;

MOVED: {THORNE, (Prince Charles) / MCLEOD, (Sullivan Heights)} BE IT RESOLVED that:

- 1. Section D12.3 be amended by:
  - (a) adding the phrase, "Subject to D13," at the beginning;
  - (b) striking the word "start" and replacing it with "first day";
  - (c) adding the phrase, "restricted competition in" before the phrase "any school sport(s)" in the first paragraph; and,
  - (d) deleting the entire second paragraph beginning with "If the student does not".
- 2. The introductory paragraph in D12.3.3 be repealed and replaced with the following;
  - D12.3.3 Change of Principal Residence: the student-athlete and his or her parent(s) or legal guardian(s) [See Definitions] have changed their principal residence in the previous twelve (12) months. The change of residence must not be for the purpose of making the student-athlete eligible for restricted competition at a member school. The student-athlete does not become eligible under this category until the member school submits to BCSS a statutory declaration by the parent or legal guardian in a form acceptable to the Executive Director which attests to the details and reason for the change of residence.

[the rest of D12.3.3 to remain unchanged]

#### 3. Section D12.3.4 be amended by:

- (a) Striking the words "during the five (5) year eligibility period," and replacing them with "after the first day of the student-athlete's third year of eligibility";
- (b) Adding the following sentence after "third year of eligibility":

The move must not be for the purpose of making the student-athlete eligible for restricted

competition at a member school.

(c) Repealing the final paragraph beginning with "An official statutory declaration" and replacing it with the following:

The student-athlete does not become eligible under this category until the member school submits to BCSS a statutory declaration by the receiving parent in a form acceptable to the Executive Director which attests to the details and reason for the change of residence.

#### 4. The following be added as D12.3.4A:

- D12.3.4A

  Move to Legal Guardian: The rules in D12.3.4 apply with necessary changes where a student-athlete moves from any living circumstance to live with a legal guardian [See Definitions]. The student-athlete does not become eligible under this category until the member school submits to BCSS a statutory declaration by the legal guardian in a form acceptable to the Executive Director which attests to the details and reason for the change of residence.
- 5. The definition of "Legal Guardian" in the definitions section of the Competitive Rules and Regulations be repealed and replaced with the following:

<u>Legal Guardian</u>: includes a person having custody rights recognized by law by virtue of a court order or written agreement.

Peter Ruocco asked for clarification on this item and clarification was provided by Kurt Wedel.

MOVED: (THORNE, {Prince Charles} / SEMENOFF, {Brocklehurst}) that an amendment is granted to strike the words "by virtue of a court order or written agreement"

<u>Legal Guardian</u>: includes a person having custody rights recognized by law <del>by virtue of a court order or written agreement</del>.

#### 6. The following be added as section D12A:

Section D12A: ADVANCE RULING ON ELIGIBILITY

- D12A.1 A member school may apply in writing to the Eligibility Officer through the BCSS office for an advance ruling on a student-athlete's eligibility to participate in restricted competition at the school for one or more sports.
- D12A.1A An application for the current school year may be brought at any time.
- D12A.1B An application for the following school year may only be brought after the BCSS Annual General Meeting for the current school year.
- D12A.2 An application under D12A.1 shall contain a completed and signed BCSS Eligibility Advance Ruling Form.
- D12A.3 The Eligibility Officer may request further information from the applicant school, and may decline to issue a ruling if he or she considers that the applicant school has not provided sufficient information.
- D12A.4 Subject to D12A.3, the Eligibility Officer shall issue a written ruling to the applicant school stating that the student-athlete is eligible or ineligible for restricted competition in one or more sports for the current or following year based on the facts submitted by the applicant

school.

- D12A.5 Where a student-athlete is ruled ineligible, the student-athlete is deemed to be ineligible for the purposes of sections C5 (Violations of Eligibility Policies) and D1 (Student Eligibility) for the year and sport or sports referred to in the ruling.
- D12A.6 Where a student-athlete is ruled eligible, the student-athlete is deemed to be eligible for the purposes of sections C5 (Violations of Eligibility Polices) and D1 (Student Eligibility) for the year and sport or sports referred to in the ruling, provided, however, that:
  - (a) the facts submitted by the applicant school are correct; and,
  - (b) the student-athlete:
    - (i) is not ineligible for restricted competition on the basis of facts not contained in the application; and,
    - (ii) does not become ineligible after the ruling is issued.

#### 7. Section D13 of the Competitive Rules and Regulations be repealed and replaced with the following:

#### Section D13: ELIGIBILITY EXEMPTION APPLICATIONS

- D13.1 Where a student-athlete is ineligible for competition pursuant to the Competitive Rules and Regulations, the member school may apply for an exemption for the student-athlete in accordance with this section.
- D13.2 An application under D13.1 shall be submitted to the 'Eligibility Officer' through the BCSS office.
- D13.3 The application shall contain:
  - (a) a completed and signed BCSS Eligibility Exemption Application Form;
  - (b) if the ineligibility arises from a school transfer, a letter from the Administrator of the student-athlete's former school confirming that the school is aware of the exemption application and indicating whether the school supports or objects to an exemption, together with its reasons;
  - (c) a copy of the student-athlete's personal record card (public schools), or report cards and transcripts (non-public schools);
  - (d) a list of the student-athlete's current courses;
  - (e) a copy of a primary source document showing the student-athlete's date of birth (e.g., birth certificate, passport, baptismal certificate, permanent resident card, provincial ID card);
  - (f) a letter from the student-athlete's parent or legal guardian supporting the application;
  - (g) copies of relevant medical documentation where the application is based on medical grounds; and,
  - (h) any other information or material the school wants the Eligibility Officer to consider.
- D13.4 The applicant school shall submit a \$50.00 application fee with each application.
- D13.5 The Eligibility Officer may request further information from the applicant school.
- D13.6 There is no right to a teleconference or oral hearing before the Eligibility Officer.

- D13.7 The Eligibility Officer may allow or deny the application, having regard to the following principles:
  - the primary purpose of the eligibility criteria in the Competitive Rules and Regulations is to promote fair and equitable competition for all student-athletes participating in BCSS competition;
  - (b) in the case of school transfers, although there are many bona fide reasons why a studentathlete might change schools, an exemption should almost invariably not be granted in respect of a transfer for the purpose of playing a sport still offered by the student-athlete's former school; and,
  - (c) an exemption shall be granted where the Eligibility Officer is satisfied that:
    - (i) the student-athlete has transferred schools for a bona fide academic reason;
    - (ii) the student-athlete has transferred schools because of financial hardship; or,
    - (iii) in any other case, the exemption would not unduly prejudice the BCSS goal of fair and equitable competition.
- D13.8 The Eligibility Officer shall issue a written ruling to the applicant school (to the attention of the Administrator and the Athletic Director) either allowing or denying the application, and containing a brief summary of the reasons for the decision.
- D13.9 Subject to D13.21, if the Eligibility Officer allows the application, the student-athlete becomes eligible for competition on the date the decision is issued, provided, however, that the student-athlete's eligibility remains otherwise subject to the Competitive Rules and Regulations.
- D13.10 It is the responsibility of the applicant school to notify the student-athlete and the student-athlete's parent(s) or legal guardian(s) of the decision of the Eligibility Officer and of any requests or other communications from the Eligibility Officer.
- D13.11 A member school may appeal a decision under D13.8 denying an exemption application, in accordance with this section.
- D13.12 An appeal under D13.11 shall be in writing and shall be submitted to the BCSS head office for forwarding to the Eligibility Appeals Committee (the "EAC") at least eight (8) days before the next scheduled meeting of the EAC.
- D13.13 The appeal shall contain:
  - (a) a completed and signed BCSS Eligibility Appeal Form;
  - (b) copies of all of the materials submitted to the Eligibility Officer;
  - (c) a cheque for \$200.00 which is refundable if the appeal is allowed; and,
  - (d) any other information or material that the school wants the EAC to consider.
- D13.14 The EAC may request further information from the applicant school.
- D13.15 There is no right to a teleconference or oral hearing before the EAC.
- D13.16 The EAC may allow or dismiss the appeal, having regard to the principles set out in D13.7.
- D13.17 The EAC may substitute its views for that of the Eligibility Officer.
- D13.18 The EAC shall issue a written ruling to the applicant school (to the attention of the administrator

and the Athletic Director) either allowing or dismissing the appeal, and containing a brief summary of the reasons for the decision.

- D13.19 Subject to D13.21, if the EAC allows the appeal, the student-athlete becomes eligible for competition on the date the decision is issued, provided, however, that the student-athlete's eligibility remains otherwise subject to the Competitive Rules and Regulations.
- D13.20 It is the responsibility of the applicant school to notify the student-athlete and the student-athlete's parent(s) or legal guardian(s) of the decision of the EAC and of any requests or other communications from the EAC.
- D13.21 Where an exemption is granted by the Eligibility Officer or by the EAC on the basis of a transfer for an academic reason, the exemption shall cease to have effect if the student-athlete withdraws from the program, group of courses or other academic offering underlying the exemption, unless and until the Eligibility Officer, on written application by the school, confirms the exemption.
- D13.22 The decisions of the EAC under D13.18 and the Eligibility Officer under D13.8 are final and binding and shall not be questioned or reviewed in any court or tribunal, and no order shall be made or process entered or proceeding taken in any court or tribunal whether by way of injunction, declaration, prohibition or otherwise to question, review, prohibit or restrain the proceedings.

It is the intention of BCSS and its members that, to the extent permitted by law, all matters concerning its Competitive Rules and Regulations be private matters not subject to any form of adjudication by any court or tribunal.

8. Section D12.5 be repealed.

# E) PROPOSED RESOLUTIONS FOR THE 2009 BCSS AGM SUBMITTED BY THE MEMBERSHIP

**15.** D2.6 Participation of Students in Kindergarten to Grade 7

WHEREAS, there is an inequity in the differential treatment of grade 7 students at elementary schools and grade 7 students at middle schools and grade 7 students at elementary-junior secondary schools under the current eligibility rules;

AND

WHEREAS, in the interest of fairness and equal opportunity for all grade 7 students;

#### AND

WHEREAS, an elementary-junior secondary school (e.g. Jaffray) can have both grade 7's and grade 8's on their bantam teams as can middle schools for (gr6 to 8);

#### **AND**

WHEREAS, a small town 8 to 12 high school (e.g. Selkirk Secondary, Kimberly) can only draw from the grade 8's in their buildings and not the grade 7's at their feeder schools;

WHEREAS, the impact of not allowing grade 7's from K to 7 schools to play on bantam teams at their local 8 to 12 high school is causing small town 8-12 high schools to be unable to field enough players for bantam teams, this hurting bantam athletes;

#### **AND**

WHEREAS, the impact of not allowing grade 7's from K to 7 schools to play on bantam teams at their local 8 to 12 high school is hurting the development of grade 7 athletes by denying them meaningful competition.

#### **AND**

WHEREAS, the motion specifically pertains to team sports (i.e. basketball, volleyball) and not individual sports (i.e. wrestling);

#### AND

WHEREAS, there is a declining participation rate at this level that will impact BCSS for senior competition over the next 5 years;

#### AND

WHEREAS, the advantages of proceeding with inclusion of all grade 7's province wide outweigh the disadvantages.

**MOVED: (MARTIN, (Selkirk)/POPOFF, (Prince Charles))** BE IT RESOLVED that elementary schools be allowed to become member schools in 2010-2011 for a fee of \$100 per year and that grade 7 students in these schools be allowed to participate in BCSS sanctioned team sport activities for the more senior school into which they would normally feed.

Much discussion followed this item in relation to the intent of the rule and its potential implications. Those opposed included J. Mitchell (on behalf of Colleen and Gordie Howe Middle School), M. Alina (Point Grey), G. Johnstone (Sentinel).

Those in favour included Sharon Popoff (Prince Charles).

MOVED: (THORNE, {Prince Charles} / SEMENOFF, {Brocklehurst}) to defer the motion back to the Committee and bring it forward again next year, taking into account the rule pertaining to joint teams and rural communities.

# **16.** Section E3 Approved Exceptions to the Seasons of Play Dates

WHEREAS, due to the unavailability of football equipment, it is all rented from Prince George Minor Football and they will not release it out until August, it is an impossibility to run any spring practice sessions. With this in mind the NCDSAA would like to apply for a specific exception that will allow it to forego E3.3.1 (p. 100) "a school team may meet another team in a jamboree with several school teams on one (1) occasion between the date of the last provincial championship and the end of the school year. This should be in

conjunction with the spring practice" and instead run the two (2) weeks of spring practices in conjunction with the two (2) weeks of practice prior to Labour Day that BCHSFA already allows for, to therefore extend allowable practices to four (4) weeks prior to Labour Day.

The exemption would be added into the BCSS handbook as E3.3.1.1 as follows:

**MOVED:** {THOMSON, (Prince George) / TOLL, (D.P Todd)} BE IT RESOLVED that NCDSAA Member Schools will have the option to run the two (2) weeks of spring practices four (4) weeks prior to Labour Day in lieu of the usual spring dates.
