- Quorum (20% of 426 members) is 86 votes registered in person and online by 10 am and all 7 zones represented. There are 90 members registered (54 in person and 36 on-line) and all 7 zones are represented.
- Special Resolutions to amend/revise the Constitution and Bylaws require 75% of the registered votes (90x75%=68)
- Resolutions to set membership fees or amend Competitive Rules & Regulations must be approved by a majority of registered votes (90x50%=46)

We are in a very stable position now with three sources of income: membership fees, gaming grants and partnerships. The gaming grant for next year is \$200,000 up from \$38,000 two years ago. Last year we also received \$50,000 to redo the registration system. The Board of Directors will approve the 2014-2015 budget at the next Board meeting.

### 6.2.4. Resolutions – Section III Competitive Rules and Regulations

### **6.2.4.1.** Senior Athlete Definition Update

Whereas, the definition for a senior athlete contains some outdated information since the change in the policy regarding players playing up to a more senior team came into effect

### MOVED {Ohl (Claremont)} SECONDED {Ravenhill (Reynolds)} BE IT RESOLVED THAT:

The definition for a senior athlete will be altered by removing the following wording:

....who has participated in more than the allotted number of sportspecific Senior competitions (see section IIID3). Allotted Senior competitions are four (4) playing days of which no more than (2) can be restricted provincial qualifying / provincial tournament

### AND BE REPLACED WITH:

A Senior Athlete is:

- Any student athlete in their fourth (4<sup>th</sup>) or fifth (5<sup>th</sup>) year of eligibility.
- A first (1<sup>st</sup>) or second (2<sup>nd</sup>) year student-athlete who plays up to the senior level will not lose grade 9 or junior eligibility for the next school year, provided that the student-athlete is eligible in all other aspects.

### 6.2.4.2. Girls Volleyball Tiering Assessment Change

Whereas, at the 2012/13 BC School Sports AGM a motion was passed to change the tiering protocols, Girls' Volleyball commission has experienced significant challenges with the "new" tier policies. While Girls' Volleyball commission supports the use of the new tiering protocol by all interested commissions, we would like to re-instate the "old" policies for our practise. [We are prepared to do the necessary work associated with insuring that our member schools are tiering correctly].

C7.1.1 Number calculation for member schools registering for Girls' Volleyball: population numbers will be determined using the current number of girls in grades 11 and 12 as submitted in this year's 1701 form.

### 6.2.4.3. Movement Between Teams

Whereas, there has been important information missing since the change in the policy regarding players playing up to a more senior team came into effect.

### MOVED {Ohl (Claremont)} SECONDED {Ravenhill (Immaculata)} BE IT RESOLVED THAT:

The following rule be added:

D.3.6-Movement between teams - A registered Student-Athlete may play up to a more senior team during league play without restriction on the number of days. Once the player has participated in playoffs the player must stay up with the more senior team, and a "Moving player to a higher age group" form must be completed. Once approved, the student will be registered with the more senior team for the remainder of that season. If a school registers two or more teams in the same age group in the same sport, there will not be any movement between those two teams for restricted competitions.

(The old D3.6 will become D3.7)

### 6.2.4.4. Grade 7 Eligibility

Whereas, all students housed in the same high school should have equal opportunity to participate on sports teams for that high school; and

**Whereas,** Grade seven students in rural districts are being forced out of elementary schools and are attending secondary schools that start at grade seven, and as a result currently cannot participate in elementary nor Bantam level sports.

### MOVED {Johnson (Fernie)} SECONDED {Sopko (Sparwood)} BE IT RESOLVED THAT:

### The following rule be repealed:

D4.1 Student athletes are athletically eligible for five years, from entry into Grade 8.

### And be replaced with:

D4.1 Student Athletes are athletically eligible for five years, from entry into Grade 8, unless they are attending a secondary school that starts at grade 7, then athletes are athletically eligible for six years, from entry into Grade 7.

### 6.2.4.5. Joint Team – Maple Ridge

Whereas, The BC School Sports Mission, Vision and Values statement and School Sports Canada charter supports allowing Student-Athletes to play sports within the BC School Sports organization while remaining at the school of their choice. BC School Sports eligibility rules section IIID state: "BCSS recognizes the right of all Student-Athletes to choose which school they attend and which subjects they study.....The overriding purpose of these rules is to ensure fair and equitable competition for all Student-Athletes participating in BCSS restricted competition." School Sports Canada, of which BCSS is a member, provides the following Vision statement for use by members; "Their sport system advances the widest array of athletic goals of all participants, with or without disability, free from discrimination and barriers based on personal circumstances." BCSS regulations currently interpreted do not fulfil this mission for Student-Athletes of small nonrural Member Schools that cannot host a team due to insufficient numbers. Students with passion, skill and ability are denied the opportunity to compete primarily based on BCSS Rule D2.1 The Rule D6.1 recognizes insufficient numbers as a rationale for allowing joint school participation, however its application to only rural schools is discriminatory to other small non-rural schools having the same situation of lack of numbers of Student-Athletes. The purpose of this proposal is to incorporate a change of wording into the BCSS rules and regulations to allow for any small Member School, regardless of location (ie rural or non-rural), that are not able to field a team due to insufficient numbers in all sports to participate with another Member School as a joint team within their zone. Please refer to research on separate 2 page document.

## MOVED {Sawka (Maple Ridge Christian School), SECONDED (Connor (Maple Ridge Secondary)} BE IT RESOLVED THAT:

### The following rule be repealed:

Section III D6.1 There is merit in allowing Student-Athletes to participate in sports programs that are not offered at their home school due to insufficient numbers in small rural or isolated communities. D6.2 Two (2) or more schools or isolated (see definitions) Member Schools may make an application to the Eligibility Officer to sponsor a joint Team which will involve the participation of Student- Athletes from more than one (1) member School

### And be replaced with:

Section III D6.1 In the event that a BCSS member school is unable to provide a team(either junior or senior) in the team sports of basketball, volleyball, soccer, and football due to insufficient numbers, individual Students-Athletes from a school may participate with another BCSS Member School within their zone. Section D6.2 Two (2) or more Member Schools may make an application to the Eligibility officer to sponsor a joint Team which will involve the participation of Student-Athletes from more than one (1) Member School.

### 6.2.4.6. Joint Team - Competitive Standards

Whereas, the BC School Sports Mission, Vision and Values statement and School Sports Canada charter supports allowing Student-Athletes to play sports within the BCSS organization while remaining at the school of their choice. BCSS regulations currently interpreted do not fulfil this mission for Student-Athletes of small non-rural Member Schools that cannot host a team due to insufficient numbers. Students with passion, skill and ability are denied the opportunity to compete primarily based on BCSS Rule D2.1. D6.1 recognizes insufficient numbers as a rationale for allowing joint school participation, however its application to only rural schools is discriminatory to other small non-rural schools having the same situation of lack of numbers of Student-Athletes.

BE IT RESOLVED THAT:

The following rule be amended:

Section III D6: Jointly Sponsored Teams

TO BE REPLACED WITH:

Section III D6: Jointly Sponsored Teams

D6.1 There is merit in allowing Student-Athletes to participate in sports programs that are not offered at their home school due to insufficient numbers.

D6.2 Two (2) or more Member Schools may make an application to the Eligibility Officer to sponsor a joint Team which will involve the participation of Student-Athletes from more than one (1) Member School.

D6.3 Each application must:

D6.3.1 be made for Team sports only;

D6.3.2 be made with regard to Member Schools that are located in the same Local Association;

- D6.3.3 be for a minimum period of one (1) year; and
- D6.3.4 Acknowledgement and support from the Member Schools' administration, Local Association President of the conditions of the application (see D6.5).

D6.4 In deciding whether or not to grant an application for a joint Team, the Eligibility Officer shall consider, but is not limited to, the following:

- D6.4.1 the goal of allowing joint Teams is to increase the number of Student-Athletes that participate in activities by making activities available for Student-Athletes that would not otherwise be available if joint Teams were not accepted;
- D6.4.2 it is preferable to combine smaller schools rather than having a small school combine with a larger school;
- D6.4.3 improving the quality of a Team (i.e. better win/loss record) shall not be a criterion in deciding whether approval will be granted.

D6.5 an approved joint Team application may have restricted access to sanctioned events.

- D6.5.1 rural or isolated (see Definitions) Member Schools, who are approved for a joint Team will not have any restricted access to sanctioned events.
- D6.5.2 with the exception of D6.5.1, joint teams may have conditions of play placed as agreed to in D6.3.4 which may include but not restricted to:
- D6.5.3 access to local leagues, access to Tier II leagues, or access to local Championships or other restrictions agreed to by the member schools' administrations and Local Association president in D6.3.4; however,
- D6.5.4 no joint team that did not qualify under D6.5.1 will be able to participate in any post season play beyond a local or Tier II championship.
- D6.6 When an application is granted, the tiering classification of the joint Team will be determined by the combined population of the two (2) schools forming the joint Team.

D6.7 The Eligibility Officer may terminate a joint Team before the expiry of the one (1) year period in the following cases:

- D6.7.1 closure of one (1) of the participating schools, or
- D6.7.2 serious breach of the Bylaws, policies or Rules and Regulations of BCSS by any of the participants, or
- D6.7.3 when, in the opinion of the Eligibility Officer, it is in the best interests of the Student-Athletes of one (1) or more schools.

D6.8 The Eligibility Officer's decision is final and conclusive and shall not be appealed or reviewed in any manner

### 6.2.4.7. Addition of wording into D11.7

**Whereas,** the lawyers recommended we add the preamble from the 2009 rules back in

MOVED: {ROWELL (ROBERT BATEMAN) / MISIAK (EARL MARRIOTT)} BE IT RESOLVED THAT:

The following be repealed:

- D11.7 The Eligibility Officer may allow or deny the application, having regard to the following principles:
- (a) the primary purpose of the eligibility criteria in the Competitive Rules and Regulations is to promote fair and equitable competition for all Student-Athletes participating in BCSS competition;
- (b) in the case of school transfers, although there are many bona fide reasons why a Student-Athlete might change schools, an exemption should almost invariably not be granted in respect of a transfer for the purpose of playing a sport still offered by the Student-Athlete's former school; and,
- (c) an exemption may be granted where the Eligibility Officer is satisfied that:
  - (i) the Student-Athlete has transferred schools for a bona fide academic reason;
  - (ii) the Student-Athlete has transferred schools because of financial hardship; or,
  - (iii) in any other case, the exemption would not unduly prejudice the BCSS goal of fair and equitable competition.
- (d) In situations not provided for in these Eligibility Policies or where extraordinary circumstances inhibit a student's opportunity to participate in school athletics, the Eligibility Officer and Eligibility Appeals Committee shall be empowered to exercise their authority to waive the eligibility rules to ensure a fair and reasonable decision as per the philosophy of BCSS.

### Be replaced with

- D11.7 The Eligibility Officer may allow or deny the application, having regard to the following principles:
- (a) the primary purpose of the eligibility criteria in the Competitive Rules and Regulations is to promote fair and equitable competition for all Student-Athletes participating in BCSS competition;
- (b) in the case of school transfers, although there are many bona fide reasons why a Student-Athlete might change schools, an exemption

should almost invariably not be granted in respect of a transfer for the purpose of playing a sport still offered by the Student-Athlete's former school; and,

- (c) an exemption may be granted where the Eligibility Officer is satisfied that:
  - (i) the Student-Athlete has transferred schools for a bona fide academic reason;
  - (ii) the Student-Athlete has transferred schools because of financial hardship; or,
  - (iii) in any other case, the exemption would not unduly prejudice the BCSS goal of fair and equitable competition.
- (d) In situations not provided for in these Eligibility Policies or where extraordinary circumstances inhibit a student's opportunity to participate in school athletics, the Eligibility Officer and Eligibility Appeals Committee shall be empowered to exercise their authority to waive the eligibility rules to ensure a fair and reasonable decision as per the philosophy of BCSS.

### 6.2.4.9 Boys Basketball Season Change

Whereas, The BCHSBBA has secured a Championship Venue (LEC) to Host all 4 Tier Championships during the week of March 11 to March 15, 2015.

- E3.1.2 Basketball AAA: For BC High School Boys Basketball Association the season of play would be extended by one week for AAA for one year only; 2013 2014 Season. The expectation is that AAA will revert back to the regular 13 weeks for season of play for 2014-2015. Restricted play for the AAA will begin one week later in the 2013-2014 season; thus beginning December 2, 2013.

### Be replaced with:

- E3.1 Boys Basketball (A, AA, AAA, AAAA) Season of play will begin on the fourteenth (14th) week (2nd Monday of the Winter Season) and finish in the twenty seventh (27th) weekend (2nd Saturday of the Spring Season) of play during the school year.
- E3.1.1 For the 2014-15 season of play only, those schools who have a tradition of having the season opening tournament on the weekend of the thirteenth (13th ) week, will have a one (1) year grace to hold such tournament in order to give the organizers time find a new date to host such tournaments.

The following rule be repealed:

I2.1 Any Member School hosting a tournament, meet, or event involving four (4) or more schools where one (1) or more

- schools are from the United States, must submit an Application for Sanction of an Athletic Competition Involving US School(s) to the BCSS Executive Director no later than sixty (90) days prior to the event.
- I2.2 Upon receipt of an application in Section III I2.1, the Executive Director will:
  - 12.2.1 ensure that the competition is being conducted in the best interests of the schools concerned.
  - 12.2.2 complete and forward endorsement forms to the executive director of the state association from which schools have been invited to participate
    - (a) tournaments, meets or events involving schools from three (3) or more states must also receive sanction from the National Federation of State High School Associations. This process requires:
      - (i) a \$75 processing fee sent ninety (90) days before the tournament, meet or event
      - (ii) a financial report sent within ninety (90) days after the tournament, meet or event
  - I2.2.3 Member schools not completing the required application form in accordance with Section III I2.1 will be fined \$200 per instance.

### 13 International Contests and Cultural Exchanges

13.1 Any member School hosting or travelling to another country other than the United States must submit an Application for Sanction of International Athletic Competition to the Executive Director no later than sixty (60) days prior to the event.

### Be replaced with:

- I2.1 Any Member School hosting a tournament, meet, or event involving four (2) or more schools where one (1) or more schools are from the United States, must submit an Application for Sanction of an Athletic Competition Involving US School(s) to the BCSS Executive Director no later than sixty (60) days prior to the event.
- 12.2 Upon receipt of an application in Section III I2.1, the Executive Director will:
  - I2.2.1 ensure that the competition is being conducted in the best interests of the schools concerned.
  - I2.2.2 complete and forward endorsement forms to the executive director of the state association from which schools have been invited to participate
    - (a) tournaments, meets or events involving schools from three (3) or more states must also receive sanction from the National Federation of State High School Associations. This process requires:
      - (i) a \$75 processing fee sent ninety (90) days before the tournament, meet or event

(ii) a financial report sent within ninety (90) days after the tournament, meet or event

I2.2.3 Member schools not completing the required application form in accordance with Section III I2.1 will be fined \$200 per instance.

### 13 International Contests and Cultural Exchanges

I3.1 Any member School hosting or travelling to another country including the United States must submit an Application for Sanction of International Athletic Competition to the Executive Director no later than sixty (60) days prior to the event.

### Facilitated by Christine Bradstock

- What is the definition of a non-public school?
- Some members want public (governed by publicly elected trustees)/non-public schools to have separate championships to maintain competitive balance.
- Question: How does the membership feel about the difference between public and independent schools?
- Question: What is the motivation of the VSSAA to ask for this?
- Question: Does this issue exist in other Athletic Associations?
  - Okanagan has not been asked for input but will participate in discussion if invited.
  - Surveys were sent 3 years ago (Competitive Issues Committee) and results indicated that this was not an issue.
- Programs attract kids in both public and independent schools prior to grade 8.
- Comment from an independent school: coaches are not paid, enrolment is open to all students regardless of faith, do not have the means to attract athletes, and just as all public schools are different, all independent schools are different as well.
- BCSS Board is required to support the Membership's Mission, Vision and Values and provide opportunities for as many students as possible to participate. Competitions

- based on school type excludes participation. BCSS staff operate on mandate of the Board of Directors and not due to a perceived conflict of interest.
- Comment from a member who attended private school 12 years, coached 10 years at
  private schools, taught 35 years at public schools: this discussion creates unnecessary illwill, 6 out of 7 zones allow public and independent to compete against one another in
  their athletic associations without conflict. The BCSS Board may need to help end the
  torment for the one zone that operates differently so that we can carry on business.
- Membership may ask BCSS Board to study this issue.
